

# Freedom Solar "Energy Independence Celebration" Customer Powerwall Giveaway Rules

### Overview:

Freedom Solar is offering a giveaway to current residential customers who refer the most new residential customers to Freedom Solar in July 2021.

### Timeframe:

- Referrals must be submitted from July 1st July 31st 2021
- Referrals must sign a contract for solar (as defined below) by September 30th, 2021

### Giveaway:

Freedom Solar will cover the standard cost of installation and equipment for one Tesla Powerwall 2 (a value of up to \$20,000). Any add-ons that may be required to complete the Powerwall installation will be the responsibility of the customer. Alternatively the winner can choose to accept a cash value of (\$7,500) in lieu of the Tesla Powerwall 2 + standard installation.

### <u>To win</u>:

The customer that submits the highest number of referrals in July who "go solar" with Freedom Solar will win the giveaway. A tie will result in a random drawing for the winner. The winner must have a minimum of 5 referrals who sign a contract to go solar with Freedom Solar by the end of September.

### <u>Terms:</u>

To qualify, current residential customers must submit potential referrals via the Advocator app with the product 'Powerwall Giveaway'.

A referral that counts towards for purposes of the giveaway is defined as follows:

A. A new customer (e.g. someone does not have solar on their roof now and who has not gotten a system from Freedom Solar in the past); and

B. Signs a contract to purchase a SunPower home solar power system from Freedom Solar (minimum system size of 2.8kW DC); and

C. Provides a deposit (if a cash deal) or Notice to Proceed (NTP) from the lender (financed deals) prior to September 30, 2021.

## Participant Eligibility:

- Must be the homeowner and a current customer of Freedom Solar
- Must be 18 years of age or older at the time of entry
- Freedom Solar Power employees, their immediate family members (spouses, domestic partners, parents, grandparents, siblings, children and grandchildren), and affiliates, advisors or advertising/promotion agencies (and their immediate family members) are not eligible to win.

## Installation

The winning participant must schedule the installation of the Powerwall directly with Freedom Solar Power. In the event there is a backlog on Powerwall orders Freedom Solar Power is not responsible for the wait time to complete the installation. Installation must occur within a reasonable distance from one of Freedom Solar's Office Locations at a residential on-grid location. Restrictions may apply to Freedom Solar's ability to install the Powerwall based on geographic location, electrical utility, and other factors.

### **Requirements**

All federal, state, and local tax liabilities are the sole responsibility of the winner. No transfer, substitution, or cash equivalent for the prize is permitted, except by Freedom Solar in its sole discretion. Winner will be required to complete and return an IRS 1099-MISC form (i.e. Request for Taxpayer Identification Number and Certification) as issued by Freedom Solar.

By registering to participate in the giveaway, participants may receive e-mails and marketing materials from Freedom Solar about special promotions and product offers. A participant may choose to decline to receive notifications of such promotions and offers by following the opt-out instructions in any notification received from Freedom Solar.

### <u>Miscellaneous</u>

If Freedom Solar determines, in its sole discretion, that there is any suspected or actual electronic tampering with the giveaway, or if technical difficulties compromise the integrity of the contest, Freedom Solar in its sole discretion, reserves the right to void any entries submitted fraudulently or to cancel or modify the giveaway. By participating, participants agree to be bound by these official rules and to accept the decisions of Freedom Solar as final in all matters relating to the giveaway.
